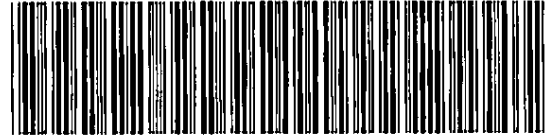

THIRD: The mailing and street address of the principal office of the Limited Liability Company is 5390 Bay Side Dr, Orlando, FL 32819.


