ARTICLES OF ORGANIZATION OF MISSION POWER, LLC

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is **MISSION POWER, LLC**.

ARTICLE II - ADDRESS

The initial address of the principal office and the mailing address of the Company is 9800 Normandy Blvd., Jacksonville, Florida 32221.

ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT


ARTICLE IV - MANAGEMENT OF THE COMPANY
