TO
ARTICLES OF ORGANIZATION

ARTICLE 1

The Articles of Organization of BLUE VISTA HOME HEALTH, LLC, a Florida limited liability company (the "Company"), were filed on August 2, 2021, and assigned Florida document number L21000348159.

The Articles of Organization are hereby amended by deleting Article 4 thereof in its entirety and substituting in its place the following:

The Articles of Organization are hereby amended by deleting Article 7 thereof in its entirety and substituting in its place the following:
