ARTICLES OF ORGANIZATION

OF

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Ch. 605, Florida Statutes (2020), as amended from time to time, the "Act").

ARTICLE I

NAME
