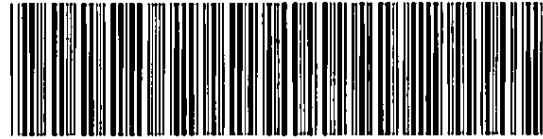

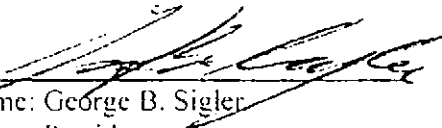
**ARTICLES OF CONVERSION

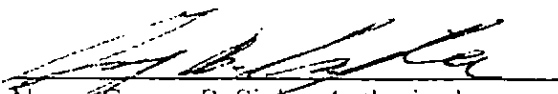
