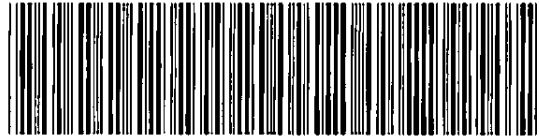

This amendment shall be henceforth known as the "**First Amended Articles of Organization.**" The Original Articles of Organization and First Amended Articles of Organization shall collectively be known as the "**Articles of Organization**" and shall be in full force and effect as of September 11, 2023, and provides as follows:

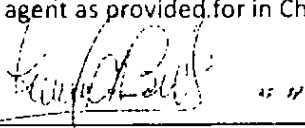

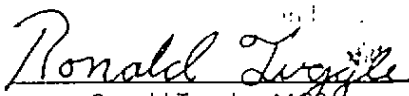
