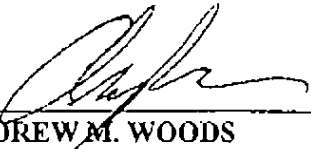
Article VIII

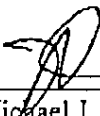
