**ARTICLES OF ORGANIZATION
OF
PORT WAREHOUSE 4, LLC**

The undersigned, Scott A. Remington, a natural person competent to contract and authorized representative of Port Warehouse 4, LLC, hereby presents these Articles of Organization as the Articles of Organization of Port Warehouse 4, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Port Warehouse 4, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 125 E. Intendencia Street, Fourth Floor, Pensacola, Florida 32502. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

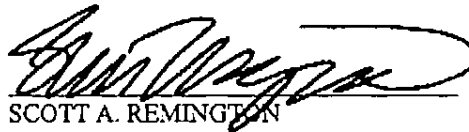
