## ARTICLES OF ORGANIZATION FOR SL26 VENTURES, LLC

### ARTICLE I - NAME

The name of the Limited Liability Company is \$L26 VENTURES, LLC.

### **ARTICLE II - ADDRESS**

Each manager shall serve until the first annual meeting of the members of the Limited Liability Company or until their successors are elected and qualify. A majority of the members owning Member Units may consent to an amendment to the Articles of Organization.
