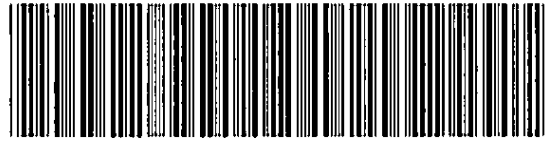

**Article 4. - Registered Office & Agent**



The Company is to be managed by managers and is, therefore, a manager-managed company and the initial managers and their address is:


