

- Affiant is attorney of record for VALUETAINMENT, LLC (the "Company") a Texas limited liability company.
- Affiant is authorized by the Engagement Agreement between the Affiant and the Company to act on behalf of the Company, and all necessary consents have been obtained.
- 3. Affiant further states that she is familiar with the nature of an oath and with the penalties as provided by the laws of the State of Texas for falsely swearing to statements made in an instrument of this nature. Affiant further certifies that she has fully read this affidavit and understands its contents.
- 4. Company formed its limited liability company in Texas several years ago under the name "VALUETAINMENT, LLC". When the company moved all offices and personnel to Florida, the Company mistakenly formed a <u>new</u> limited liability company in Florida under the same name VALUETAINMENT, LLC (L21000047223) rather than filing articles of conversion.

- Affiant, acting on behalf of Company, filed the articles of dissolution for VALUETAINMENT, LLC (L21000047223) on March 25, 2021. Such dissolution has been processed.
- 6. At the instruction of a Florida Department of State employee, Affiant included a release of the name "VALUETAINMENT LLC" within the notes of the dissolution documents.
- 7. Affiant was then instructed by the Florida Department of State employee to file the articles of conversion (W21000064928) for the Texas limited liability company and was told that the name would then be available.
- 8. However, after filing the Articles of Conversion, Affiant received a notice from the Florida Department of State (Letter 221A00009904) stating that the name VALUETAINMENT, LLC was unavailable despite the dissolution and release.
- Affiant contacted the Florida Department of State again and was told by a different employee to send this Affidavit and Release to release the name "VALUETAINMENT, LLC" in connection with the dissolved company L21000047223.
- 10. This Affidavit is now hereby given to release the name "VALUETAINMENT, LLC" in connection with the filing L21000047223. This name is to be released for Company's use in connection with the conversion of the Texas limited liability company to a Florida limited liability company (W21000064928).
- 11. The Company has no intention of revoking the articles of dissolution for the Florida limited liability company (L21000047223).
