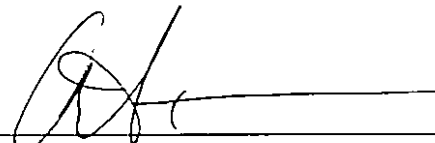

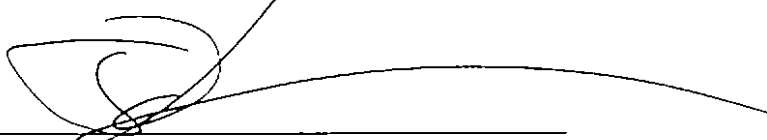

#### ARTICLE II - PRINCIPAL OFFICE

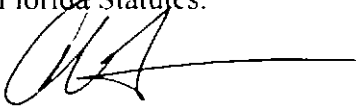

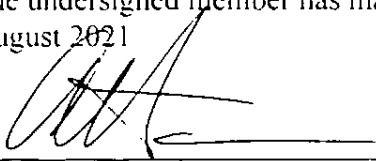
