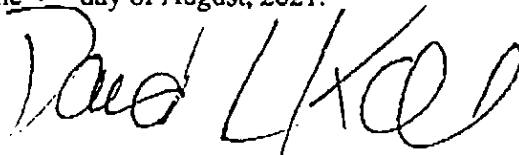
ARTICLE 5
