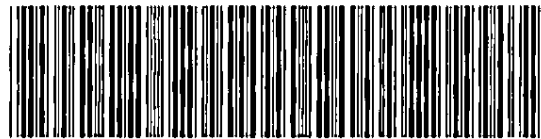

**ARTICLE 1 – NAME**

#### **ARTICLE 5 – COMPANY PURPOSE**




