ARTICLES OF ORGANIZATION OF SECT, LLC



SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization to the Florida Department of State Division of Corporations, in accordance with Chapter 605 Florida Revised Limited Liability Company Act (the Act).
