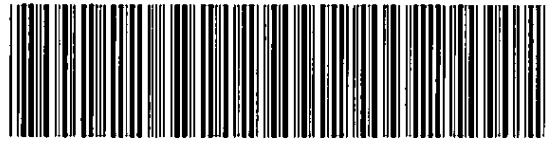

**ARTICLE II: ADDRESS**


