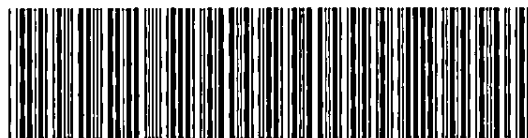

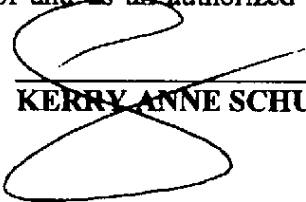
ARTICLE IX - MANAGEMENT
