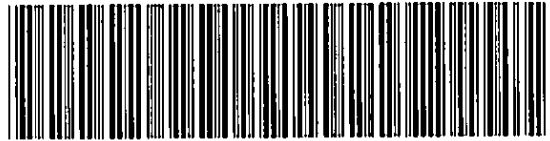

ARTICLE I. NAME


ARTICLE V. MANAGEMENT
