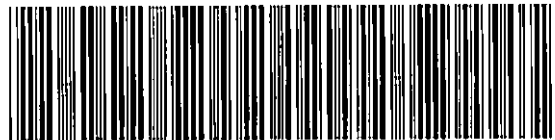

**ARTICLE I – Name**

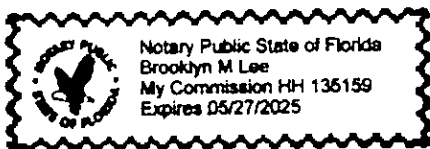
