ARTICLES OF ORGANIZATION OF HEALTH ALLIANCE OF FLORIDA, LLC

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Health Alliance of Florida, LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 500 East Central Avenue, Suite A. Winter Haven, FL 33880.

ARTICLE III. REGISTERED AGENT AND OFFICE
