**ARTICLES OF ORGANIZATION
OF
HEALTH ALLIANCE OF FLORIDA, LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Health Alliance of Florida, LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 500 East Central Avenue, Suite A, Winter Haven, FL 33880.

ARTICLE III. REGISTERED AGENT AND OFFICE

The Company designates 1200 South Pine Island Road, Plantation, FL 33324 as the street address of the initial registered office of the Company and names C T Corporation System as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE IV. DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement or pursuant to the Act, as amended from time to time.

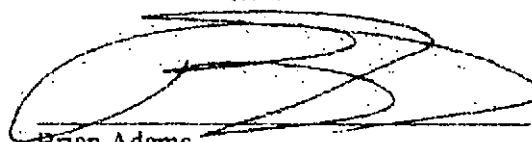
