**ARTICLES OF ORGANIZATION

Buttell, a natural person competent to contract and authorized representative of Peoples Hospice and Palliative Care, LLC, hereby presents these Articles of Organization as the Articles of Organization of Peoples Hospice and Palliative Care, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Peoples Hospice and Palliative Care, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
