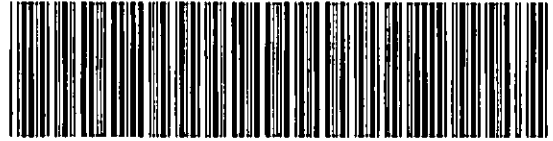




#### ARTICLE VI – MEMBERSHIP UNITS AUTHORIZED
