ARTICLES OF ORGANIZATION OF STALKER VENTURES OF FLORIDA, LLC

The undersigned, Cameron S. Price, a natural person competent to contract and an authorized representative of Stalker Ventures of Florida, LLC, hereby presents these Articles of Organization as the Articles of Organization of Stalker Ventures of Florida, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

<u>ARTICLE I - NAME</u>
