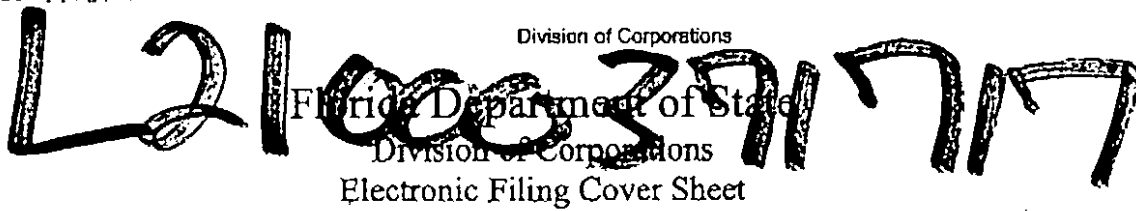


ARTICLE IX - ADOPTION OF OPERATING AGREEMENT

ARTICLE X - AMENDMENT


The Company shall have the power to amend or supplement these Articles of Organization when approved by majority vote of the members.
