ARTICLES OF ORGANIZATION

ARTICLE IV

Management of Business


The Company shall be manager-managed. The initial manager of the company shall be Michael Dris, whose mailing address is 2925 Alt 19, Suite A, Palm Harbor, FL 34683.

ARTICLE V

Membership Units

This Company shall be authorized to issue One Million (1,000,000) membership interest, no par value, which shall be divided into two (2) classes: (i) 1,000 Class A Voting Membership Units, which shall be designated as "Voting Units", and (ii) 999,000 Class B Non-Voting Membership Units, which shall be designated as "Non-Voting Units". Each of the Voting Units shall entitle the holder thereof to one (1) vote at any meeting of the members. There shall be no other difference in the rights of such membership units.

IN WITNESS WHEREOF, the undersigned Member or authorized representative of a Member has executed these Articles of Organization on August 19, 2021.

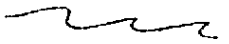
