ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF

DRIS FAMILY CAPITAL HOLDINGS, LLC

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the undersigned limited liability company, **DRIS FAMILY CAPITAL HOLDINGS**, **LLC** (the "Company"), adopts the following Articles of Amendment (the "Amendment").

- 1. <u>Name of the Company</u>. The name of the company is **DRIS FAMILY CAPITAL HOLDINGS**, **LLC**, whose Articles of Organization were filed on August 20, 2021 with the State of Florida.
- 2. **First Amendment Adopted.** The Amendment adopted provides for a change in the Membership Units as set forth in Article V of the Articles of Organization.
- 3. <u>Text of Amendment</u>. Article V of the Articles of Organization is amended by deleting such Article V in its entirety and substituting in lieu of such Article V the following Article V which reads as follows:

ARTICLE V Membership Units

This Company shall be authorized to issue One Million (1.000,000) membership interest, no par value, which shall be divided into two (2) classes: (i) 2.000 Class A Voting Membership Units, which shall be designated as "Voting Units", and (ii) 998,000 Class B Non-Voting Membership Units, which shall be designated as "Non-Voting Units". Each of the Voting Units shall entitle the holder thereof to one (1) vote at any meeting of the members. There shall be no other difference in the rights of such membership units.

4. <u>Authorization of Amendment and Effective Date</u>. The Amendment was unanimously adopted on April 20, 2023, by the Managers of the Company. The effective date of the Amendment is April 20, 2023 pursuant to Section 605.0207 of the Act.
