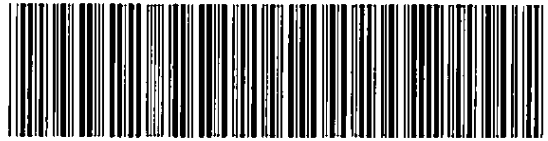

THIS STATEMENT OF CORRECTION is being made on August 31, 2021 pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act to correct the Articles of Organization ("Articles") for American Dream Landscape and Estate Management LLC (the "Company"). The Articles were filed with the Florida Department of State on August 25, 2021 under Document No. L21000379989.

1. The Articles contain an incorrect statement in that the last name of the Manager and President set forth in Article VI is incorrect. The correct name spelling of the Manager and President is Adam J. Iaquinto (last name beginning with the letter "I" as in "eye"). Consequently, Article VI should read as follows:

ARTICLE VI – INITIAL MANAGER AND OFFICER
