NEW MEMBERS**



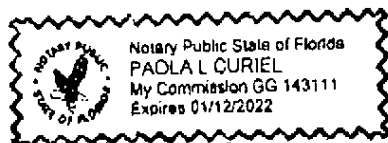
