**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME & ADDRESS**

The power to adopt, alter, amend or repeal an Operating Agreement governing the operation of the Company shall be vested in its members.


ARTICLE V

IN WITNESS WHEREOF, the undersigned authorized representative of the initial members has executed these Articles of Organization this 26th day of August, 2021.


