

- 1. <u>Name</u>, Jurisdiction, and Type of Entity of the Converting Eligible Entity. The name of the converting eligible entity immediately prior to the filing of these Articles of Conversion is BW Old School Square, Inc., a corporation formed under the laws of the State of Florida on September 2, 2015 (the "Converting Eligible Entity"). Each shareholder of the Converting Eligible Entity has approved these Articles of Conversion.
- 2. <u>Name, Jurisdiction, and Type of Entity of the Converted Eligible Entity.</u> The name of the converted domestic eligible entity is BW Old School Square LLC (the "<u>Converted Eligible Entity</u>"), a limited liability company under the laws of the State of Florida.

- 5. <u>Effective Date</u>. This conversion shall be effective when these Articles of Conversion are filed with the Florida Department of State. Division of Corporations.
- 6. <u>Appraisal Rights</u>. The Converted Eligible Entity has agreed to pay any members of the Converted Eligible Entity and any shareholders of the Converting Eligible Entity having appraisal rights, in either instance, the amount to which they are entitled under Sections 605,1006 and 605,1061-605,1072. Florida Statutes, and Sections 607,1301-607,1333. Florida Statutes, respectively.
