The undersigned, who intends to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes, does hereby state and certify the following:

1. Name. The name of the Limited Liability Company shall be APPALOOSA VENTURES, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 3948 3rd Street South #3, Jacksonville Beach, Florida 32250.

4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent is Arthur L. Cahoon, 3948 3rd Street South #3, Jacksonville Beach, Florida 32250.

10. The Articles of Organization of this limited liability company may be amended in any manner permitted by Chapter 605, Florida Statutes.




