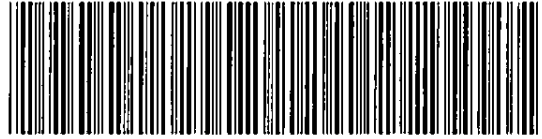

Pursuant to the provisions of §605.0701 and §605.0707 of the Florida Revised Limited Liability Company Act (the "Act") and for the purpose of effecting the dissolution (the "Dissolution") of Evolution Protection LLC, a Florida limited liability company (the "Company"), the Company has adopted these articles of dissolution (the "Articles of Dissolution").

1. The name of the Company is Evolution Protection LLC, a Florida limited liability company.

2. The Articles of Organization of the Company were filed on September 1, 2021 and assigned Document Number L21000390541.

3. Pursuant to §605.0701 of the Act, dissolution was authorized by the unanimous written consent of the managers of the Company (each a "Manager" and collectively, the "Managers") constituting the board of managers (the "Board").

4. The Company no longer holds any assets and is not conducting any business; as such, the Board desires to dissolve the Company.

5. All debts, obligations and liabilities of the Company have been paid or discharged.


6. There are no suits pending against the Company in any court.


