**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

These Articles of Amendment are being filed pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act to amend the Articles of Organization of BBX Logistics Properties LLC, a Florida limited liability company (the "Company"), as previously amended, solely to change the Company's name to Altman Logistics Properties LLC.

The Articles of Organization of the Company were filed on September 2, 2021 and were assigned Florida document number L21000391742. At the time of such filing, the name of the Company was BBX Industrial LLC. Articles of Amendment to the Articles of Organization of the Company were filed on February 23, 2022 to change the Company's name to BBX Logistics Properties LLC.

The amendment to the Articles of Organization, as previously amended, of the Company is as follows:
