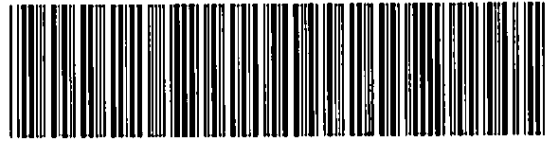

**ARTICLE IV. MANAGEMENT**

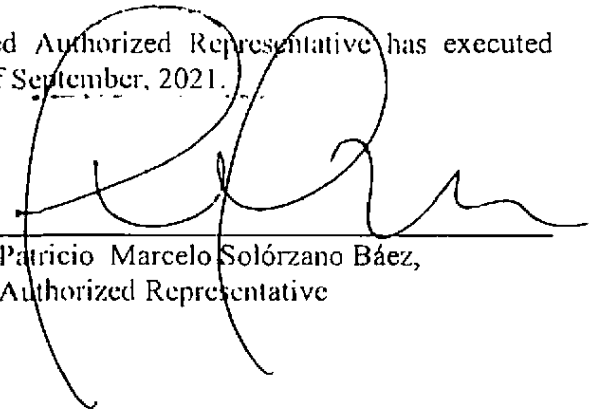
