ARTICLES OF ORGANIZATION

The undersigned, as a manager of TRG Capri Place Member, LLC, a Florida limited liability company, as sole member of RICHMAN CAPRI MARKET APARTMENTS, LLC, a Florida limited liability company (the "Company"), desiring to further amend the Articles of Organization of the Company pursuant to the terms of Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"), states as follows:

1. The current name of the Company is RICHMAN CAPRI MARKET APARTMENTS, LLC.
2. The original Articles of Organization of the Company were filed with the Florida Department of State on September 3, 2021 (the "Articles").
3. The Articles are amended by deleting Article IV in its entirety and replacing with the following:

Article IV – Management:

The Company is to be managed by its Member, unless and until one or more managers are appointed in accordance with the Operating Agreement of the Company, in which case the Company shall be managed by one or more managers.
