The undersigned, Troy Stackhouse, competent to contract and an authorized representative of 615 to 850, LLC, hereby presents these Articles of Organization as the Articles of Organization of 615 to 850, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is 615 to 850, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The date for commencement of the Company's existence shall be September 3, 2021. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

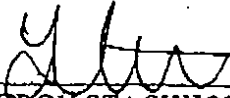
**ARTICLE V - REGISTERED OFFICE AND AGENT**
