**THIRD:** Article III of the Articles of Organization is revised to read as follows:

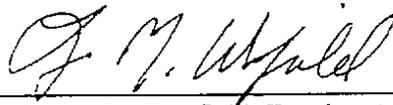
**ARTICLE III – Management and Officers**
