ARTICLES OF ORGANIZATION
of
HONEY ENTERPRISES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Honey Enterprises, LLC (the "*Company*"). The mailing address of the principal office of the Company shall be P.O. ARTICLE VII**DURATION AND COMMENCEMENT**




