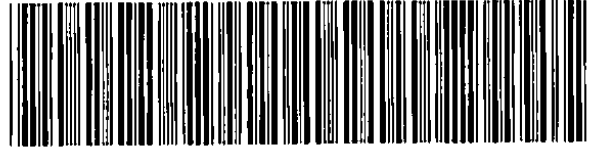

**ARTICLE I.
NAME**

The name of the Limited Liability Company is "*JB Ranch DRH of Ocala, LLC*" (the "*Company*").

**ARTICLE II.
ADDRESS**

The mailing address and street address of the principal office of the Company is 1720 SE 16th Avenue, Building 200, Ocala, FL 34471.

**ARTICLE III.
DURATION**

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*, Sections 605.0101 through 605.1108 of the *Florida Revised Statutes Annotated* (the "*Act*") or the Company's Operating Agreement among the members (the "*Operating Agreement*").

**ARTICLE IV.
MANAGEMENT**

The Limited Liability Company is to be managed by a Manager. The initial Manager shall be Roy T. Boyd, III.

**ARTICLE V.
PURPOSE**

The business of the Company is to acquire, develop, lease, and/or sell, directly in its own name or as a shareholder, member, or partner in another entity, residential, commercial or other real property, and/or to provide expertise in the acquisition, development, lease and/or resale of residential and commercial real property to third parties for a fee, and to transact business and exercise all rights and engage in all activities related thereto, and to transact any other lawful business approved by the Members of the Company and for which a limited liability company may be formed under the laws of the State of Florida.


**ARTICLE VI.


