TO
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **OCOEE VILLAGE PARTNERS, LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is **OCOEE VILLAGE PARTNERS, LLC** (the "Company").
