Articles of Organization of the Shak of Lake Mary LLC

A Florida Limited Liability Company

Section 1.01 Introduction and Preliminary Statements

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Secretary of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the Act).

Section 1.02 Name

The name of the limited liability company, referred to as the Company, is:

Shak of Lake Mary LLC, A Florida Limited Liability Company

Section 1.03 Effective Date and Duration

The Company will be effective on the date of filing and shall perpetually exist, unless dissolved according to law.

Section 1.04 Purpose

The Company is organized to conduct any lawful business or investment activities, and to exercise all of the powers, rights, and privileges granted to a limited liability company organized under the Act.

SHAK OF LAKE MARY, INC. (EIN 47-2522263) will convert from a Florida corporation to a Florida limited liability company ("LLC") effective September 1, 2021, under Florida law (the conversion transaction). As an LLC, SHAK OF LAKE MARY, INC. will be required to change its name to "SHAK OF LAKE MARY LLC".

SHAK OF LAKE MARY, INC. was incorporated in Florida on October 2, 2002. SHAK OF LAKE MARY LLC will elect to be classified as an association taxable as a corporation pursuant to Treas. Reg. Sec. 301.7701-3, effective as of the date of the conversion

transaction. (See attached IRS Form 8832). As a result, SHAK OF LAKE MARY LLC will never be treated as a disregarded entity, but will be treated as a continuation of SHAK OF LAKE MARY, INC. for income tax purposes. The conversion transaction, when combined with SHAK OF LAKE MARY LLC's election to be taxed as a corporation, will be a mere change in identity or form and will constitute a reorganization under Internal Revenue Code Sec. 368(a)(l)(F).

SHAK OF LAKE MARY LLC will retain SHAK OF LAKE MARY, INC.'s federal taxpayer identification number (see PLR 200528021, ruling 5). Under Treas. Reg. Sec. 1.381(a)(2), SHAK OF LAKE MARY, INC.'s tax year will not close as a result of the conversion transaction and no final federal income tax return will be filed. Because Florida conforms to federal entity classification rules, SHAK OF LAKE MARY LLC will continue existence as a corporation for state income tax purposes as well; SHAK OF LAKE MARY LLC will, effectively, replace SHAK OF LAKE MARY, INC. for tax purposes in Florida by operation of law and, consequently, SHAK OF LAKE MARY, INC. will not be required to file a final income tax return for federal or state purposes.

Additionally, since SHAK OF LAKE MARY LLC will continue existence as a corporation and will continue to use SHAK OF LAKE MARY, INC.'s taxpayer identification number for federal tax purposes, SHAK OF LAKE MARY LLC will continue to use the various tax accounts (e.g., sales tax, payroll withholding, corporate income tax, etc.) already established and used by SHAK OF LAKE MARY, INC. in Florida.

Section 1.10 Additional Members

The Company has the right to admit additional Members to the Company under the terms and conditions of the Company's Operating Agreement. Any Member who is later admitted as a Member of the Company will have all of the rights and obligations of an original Member under the Operating Agreement. Any transferee of a Member's Interests in the Company must be treated as an Assignee until that transferee is admitted as an Additional or Substitute Member, if ever, under the Operating Agreement.

Section 1.11 Business Continuation

If a Company Member's membership in the Company is terminated by an event, the remaining Members and Managers of the Company have the right to continue the Company's business under the terms of the Operating Agreement. A terminating event, may include the Member's death, disability, retirement, resignation, withdrawal, expulsion, or bankruptcy. If the remaining Members and Managers fail to-continue the Company's business according to the terms of the Operating Agreement, the Company must be dissolved and liquidated under the Act and the Operating Agreement.

Section 1.12 Operating Agreement and Authority

To the extent not expressly required by and provided for in the Act, the manner in which the Company conducts its business and affairs, the duties and authority of its Members and

Managers, and the rights and obligations of its Members and Managers must be set forth in the Operating Agreement adopted by the initial Members and Managers of the Company. This Operating Agreement may be amended from time to time according to its provisions.

Section 1.13 Management
