

# Articles Of Organization Of BIRMINGHAM MOTORSPORTS PARK, LLC

#### Article I Name

The name of the limited liability company ("Company") is BIRMINGHAM MOTORSPORTS PARK, LLC.

#### Article II Address

The name of this limited liability company is BIRMINGHAM MOTORSPORTS PARK, LLC and its principal office is located at 5821 PIT ROAD, BUSHNELL, FL 33513 and mailing address is PO BOX 552, BUSHNELL, FL 33513.

#### Article III Duration

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

#### Article IV Purpose and Powers

#### Article V Registered Agent and Office

#### Admission of New Members
