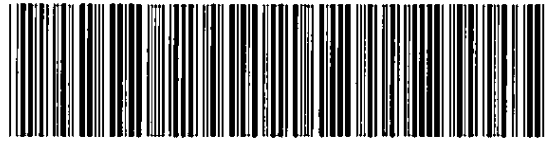

MANAGEMENT**




