September 12, 2023 Michael Alexander II accessed Aloha Property Buyers LLC on sunbiz.org fraudulently adding himself as a Registered Agent forging my signature electronically authorizing this action without my knowledge or consent. September 13, 2023 Michael Alexander II changed Manager to his name a second time removing myself from the business entity. I contacted sunbiz.org September 19, 2023 receiving assistance to correct the changes made reinstating my proper Manager status.
