- A. Article III of the Original Articles is hereby replaced in its entirety with the following:**

- B. Article IV of the Original Articles is hereby replaced in its entirety with the following:**

**ARTICLE IV – Registered Agent and Office**

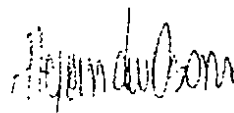
