Articles of Organization of the Lolo Joan LLC

A Florida Limited Liability Company

Section 1.01 Introduction and Preliminary Statements

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Secretary of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the *Act*).

Section 1.02 Name

The name of the limited liability company, referred to as the *Company*, is:

Lolo Joan LLC, A Florida Limited Liability Company

Section 1.03 Effective Date and Duration

The Company will be effective on the date of filing and shall perpetually exist, unless dissolved according to law.

Section 1.04 Purpose

The Company is organized to conduct any lawful business or investment activities, and to exercise all of the powers, rights, and privileges granted to a limited liability company organized under the Act.

LOLO JOAN, INC. (EIN 47-2522263) will convert from a Florida corporation to a Florida limited liability company ("LLC") effective September 1, 2021, under Florida law (the conversion transaction). As an LLC, LOLO JOAN, INC. will be required to change its name to "LOLO JOAN LLC".

LOLO JOAN, INC. was incorporated in Florida on December 10, 2014. LOLO JOAN LLC will elect to be classified as an association taxable as a corporation pursuant to Treas. Reg. Sec. 301.7701-3, effective as of the date of the conversion transaction. (See attached IRS

Lolo Joan LLC, A Florida Limited Liability Company Articles of Organization Page 1 of 4 Form 8832). As a result, LOLO JOAN LLC will never be treated as a disregarded entity, but will be treated as a continuation of LOLO JOAN, INC, for income tax purposes. The conversion transaction, when combined with LOLO JOAN LLC's election to be taxed as a corporation, will be a mere change in identity or form and will constitute a reorganization under Internal Revenue Code Sec. 368(a)(l)(F).

LOLO JOAN LLC will retain LOLO JOAN, INC.'s federal taxpayer identification number (see PLR 200528021, ruling 5). Under Treas. Reg. Sec. 1.381(a)(2), LOLO JOAN, INC.'s tax year will not close as a result of the conversion transaction and no final federal income tax return will be filed. Because Florida conforms to federal entity classification rules, LOLO JOAN LLC will continue existence as a corporation for state income tax purposes as well; LOLO JOAN LLC will, effectively, replace LOLO JOAN, INC. for tax purposes in Florida by operation of law and, consequently, LOLO JOAN, INC. will not be required to file a final income tax return for federal or state purposes.

Additionally, since LOLO JOAN LLC will continue existence as a corporation and will continue to use LOLO JOAN, INC.'s taxpayer identification number for federal tax purposes, LOLO JOAN LLC will continue to use the various tax accounts (e.g., sales tax, payroll withholding, corporate income tax, etc.) already established and used by LOLO JOAN, INC. in Florida.
