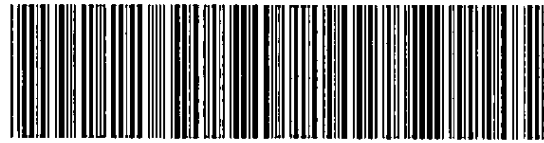

The Members reserve the right to alter, amend or repeal any provisions contained in these Articles of Organization, or to


