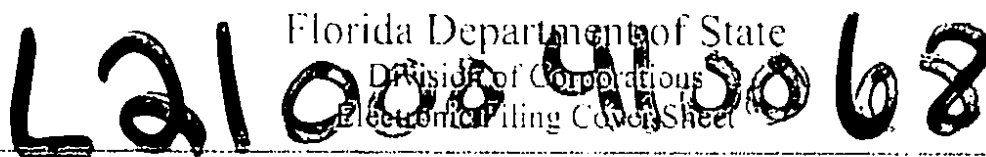

**This Amendment is submitted to amend the following:**


**A. Article IV of the Original Articles is hereby replaced in its entirety with the following:**


