ARTICLES OF ORGANIZATION

The undersigned, constituting all of the Members and Managers of the Company, and being all attorneys duly licensed to render services as such under the laws of the State of Florida, hereby confirm the Company's formation as a Professional Limited Liability Company for profit pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act of Florida, Florida Statutes Chapter 621, and the other applicable laws of the State of Florida.

ARTICLE I -- NAME

The name of the professional limited liability company shall be Affiliated Lawyers, PLLC (the "Company").

ARTICLE V – REGISTERED OFFICE AND AGENT

ARTICLE VI – CAPITAL CONTRIBUTIONS

A Member may only transfer his or her interest in the Company as set forth in the Operating Agreement of the Company or otherwise with the prior written consent of a majority of the Members.

ARTICLE IX – MANAGEMENT

The Company shall be managed by a **manager or managers** in accordance with the Articles of Organization, the Operating Agreement, the Regulations (if any) adopted by the Members for the management of the business and the ordinary and customary affairs of the Company. The Operating Agreement and/or Regulations, if any, or otherwise the minutes of the Company, shall determine the manner in which such Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the Company that are not inconsistent with the law or these Articles of Organization.
